

Requirements for Home-Based Businesses:

 Applicant's business space must be separate and distinct from the remainder of the home

Reminder

- No vacant or unoccupied buildings
- Buildings under construction or undergoing renovations are generally not acceptable

Ineligible for both Building Owners and Tenants

- Manufacturing operations
- Manufacturing operations within the same building
- Apartment or residential exposures that exceed 66% of the premises total square footage
- 24-hour operations

Ineligible for Building Owners

- Buildings greater than six stories in height (excluding basement)
- · Apartments leased to college students
- Temporary or transient housing exposures

Ineligible for Tenants

- · Space cannot be above the 40th floor
- · Operations located within:
 - An airline, bus, subway, or train terminal
 - A stadium or arena
 - An amusement park

Business Link Advantage and Business Link

Plus adds 40+ coverage enhancements including Extended Business Income, Civil Authority, and Backup of Sewer or Drain.

Business Personal Property Supplemental Coverage includes the following:

- · Property while away from the premises.
- Property of others in the care custody and control of the insured.
- Property while in transit.

Cyber suite includes data compromise, computer attack, cyber extortion, and network security liability.

Employee Benefits covers liability due to errors or omissions in the administration of an employee benefit programs.

Employment Practices Liability provides coverage for allegations of harassment, wrongful termination, failure to promote, discrimination, etc., by employees. Can be endorsed to cover liability to third parties. Up to \$500,000 available on our BOP. Higher limits available for consideration on a separate policy.

Enhanced Computer Coverage provides coverage for computer equipment including laptops.

Fine Arts extends coverage to include fine arts of the insured or fine arts of others in the insured's care.

Garagekeepers provides comprehensive and collision coverages for customer vehicles in the care of the insured.

Green Extension gives traditional buildings greener options at the time of loss and provides specialty coverages for green certified buildings.

Replacement Cost Plus increases the building limit up to 15%. It is helpful if materials and labor costs increase after a catastrophe.

Spoilage Coverage covers spoilage of perishable goods caused by loss of refrigeration or power.

PAYMENT

PLANS AND OPTIONS FOR YOUR CONVENIENCE

Down Payments

- If the 1st installment is not collected at the time the policy is written, we will bill the policyholder for the 1st installment 20 days prior to the due date chosen. If the policy was written within 20 days of the due date, then the 1st installment amount will be included with the 2nd installment amount.
- Credit/Debit Cards

Accepted on all Commercial Lines policies. Credit/Debit card payments will be accepted up to \$10,000 on Commercial Lines policies.

Checking/Savings accounts

Accepted on all Commercial Lines policies. Checking/Savings account payment method may be used for payments up to \$500,000.

Pay-in-Full

Entire premium is paid when the policy is purchased or renewed.

Recurring Electronic Funds Transfer (EFT) payments are automatically withdrawn from the policyholder's checking or savings account on the due date, based on the payment plan selected. No installment fee applies.

Recurring Debit/Credit Card payments are automatically collected from the insured's debit/credit card on the due date, based on the payment plan selected. We honor Visa, MasterCard, and Discover cards. Installment fees apply.

 Commercial Lines policies: Available on all policies. Recurring debit/credit card payment must be below the \$10,000 limit.

Online Payment

We offer several options to pay online:
